3. Data required by JadeWeserPort

For the application, we process the data provided by you which we need as part of the selection process. This data can comprise contact data, as well as all of the data used in connection with the application (CV, certificates, qualifications, answers to questions, etc.). The legal basis for this data collection is Article 26 German Data Protection Act.

4. Duration of the retention of personal data

Insofar as there is no statutory retention duration, your data is erased as soon as the retention is no longer required, and/or the justified interest in retaining this data has ended. If no employment contract is agreed, this is usually done within six months at the latest after concluding the application procedure.

In the event that no appointment is made, but we continue to be interested in your application, we will ask you if we can retain your application for consideration with respect to future job vacancies.

5. Confidential handling of your data

We naturally handle your data confidentially and do not pass this data onto any third parties. On occasions, we use service providers covered by strict regulations who provide us with support in areas such as IT or the destruction of documents, and who have closed special agreements on contractual data processing.

6. Your data protection rights

As the data subject, you have the right to receive information on your personal data, as well as the rectification of incorrect data, or erasure, as long as a reason exists as stipulated in Article 17 GDPR (Right to be Forgotten), e.g. when the data is no longer required for the intended purpose. You also have the right to restrict the processing when a condition exists as stipulated in Article 18 GDPR, as well as the right to data portability pursuant to the cases stipulated in Article 20 GDPR. Every data subject has the right to lodge a complaint to a supervisory authority if they are of the opinion that the processing of the data affecting them violates the data protection regulations. The right to lodge a complaint can be exercised in particular with a supervisory authority in the Member State of the data subject's habitual residence, place of work or place of the alleged infringement.
